**Subject:** Property Tax Sale by Public Tender

## **Background:**

The Township of South Stormont proceeds with a tax sale for qualified properties when the taxes have not been paid in accordance with the *Municipal Act, 2001*, in an attempt to recover outstanding taxes.

The recent sale of land for tax arrears by public tender closed October 26<sup>th</sup> ,2021 at 3:00 p.m. with fifteen (15) properties advertised.

The listing of properties was advertised for four (4) consecutive weeks in the local newspaper, Cornwall Standard Freeholder, published once in the Ontario Gazette during the four-week notice period, as well as on the Township's website.

In accordance with the Municipal Act,2001, the responsibility for ascertaining any matters regarding the title or any other matter relating to the land to be sold rests with the potential purchaser.

Tenders were required to be submitted on the prescribed Form 7 accompanied by a deposit in the form of a money order, bank draft or certified cheque, representing a minimum of 20% of the tendered amount to be accepted as a compliant bid.

Throughout the tax sale, the Township works with the owners to resolve the outstanding taxes and cancel the property from the sale if payment is made in full. Prior to the closing of the tender, three (3) properties were redeemed by or on behalf of their respective owners. Any bid received to a property that was cancelled had their bid and deposit returned by regular mail after the conclusion of the sale.

Three (3) properties were sold through the tender process.

The two (2) compliant high bids were retained and forwarded to Solicitor Horner to complete the tax sale transaction which includes;

- Notifying both the highest and second highest bidder
- Executing/Signing the required documents
- Provide a Deed in Fee Simple to confirm title of the property
- Paying any excess funds into court.

Nine (9) properties did not receive bids. Finance is working with the Solicitor to determine the next steps that would be in the best interest of the Township for these properties. Once options have been determined they will be brought to Council with a recommendation.

There were three (3) bids that were received after the closing time of October 26, 2021 3:00 PM and as such were rejected and returned to the bidder unopened.
