I would like to confirm a few more details of your request so our staff and Council fully understand the request;

- 1. Just want to confirm that you are making this request with hopes of relocation of the team in October 2022?
- 2. If starting in October 2022, when is the deadline for the Township to provide you with an answer about ice availability?
- 3. You indicate that you would need 3 hours of ice for 12 weeks of the season, with option of hosting additional playoff games later in the year. Can you confirm when the regular season ends, and when the playoff games could take place?
- 4. Above and beyond the ice times that you have requested, do you foresee future ice time requests at the Long Sault Arena for tryouts before the season and/or practices throughout the season?

Hi Kevin,

Thanks so much for your quick response! Those are some great questions we'd be more than happy to answer.

- 1 Yes to confirm, it is the upcoming 2022/2023 season, beginning in October 2022 that we would like to relocate to Long Sault.
- 2 We'd like to start advertising and setting up fundraisers/sponsorships soon. If we could have an answer by April 1st/2022 that would be ideal. If this is an unrealistic time frame we'd have a little wiggle room on this date, but as soon as possible would be appreciated!
- 3 Due to Covid-19 Restrictions, the season shifted slightly for the 21/22 Season.. assuming this year goes as planned, the regular Season would end mid-end of February 2023 and begin the beginning of March 2023.
- 4 In addition to the ice times previously discussed, we would request about 3 hours of ice time on a Saturday in August for tryouts (depending how early the ice is ready in Long Sault we could be flexible on when we do the try out). As the season starts up we would also be interested in booking ice time for about 1.5 hours, once or potentially twice per month for practices. We would work with the Arena/township to see when ice time is available through the week or weekends- it does not have to be scheduled or guaranteed in advance as these are just additional practices we would try to organize with the team here and there.
